**Анотація.** У статті досліджено інформаційне забезпечення та тенденції розвитку грантової діяльності в закладах вищої освіти, вдосконалення грантової діяльності у закладах вищої освіти з метою відповіді на сучасні виклики та можливості, а також з підвищенням ефективності та доступності цього інструменту для академічної громадськості. Abstract. The article examines the information support and trends in the development of grant activities in higher education institutions, the improvement of grant activities in higher education institutions in order to respond to current challenges and opportunities, as well as to increase the efficiency and accessibility of this tool for the academic community. This study aims to thoroughly analyze current trends in the grantmaking activities of Ukrainian higher education institutions (HEIs), identify important challenges and prospects for the development of this area. The main goal is to develop recommendations for optimizing the processes of attracting grant funds and supporting research and educational initiatives. The study used a variety of methods, such as analysis of scientific publications, study of statistical data, expert evaluation and comparative analysis of granting practices. This is important given the growing competition for grants, the trend toward interdisciplinarity, and the need for global cooperation. The results of the analysis can be an important source of information for the management of higher education institutions and research groups in improving their grantmaking strategies and ensuring further scientific development. This study emphasizes the key role of grantmaking in Ukrainian higher education institutions for scientific and educational development. It identifies strategies for optimizing this process in the face of current challenges and contributes to the achievement of global sustainable development goals.

The authors argue that international cooperation of Ukrainian higher education institutions is a prerequisite for this integration. This is an important element of strengthening Ukraine's competitiveness in the market of educational services. They also point out that the steadfast integration of Ukraine's higher education system into the European Higher Education Area contributes to the international rankings of Ukrainian universities.

At the same time, Kuzmenko Y. A., Valiukevych T. V. and Shevchenko I. Y. [2] study the issues of grant activities and fundraising of higher education institutions and emphasize that grant activities are mostly perceived as financial assistance for a specific project or monetary gratitude for the work done.

Havran M.I., Horokhivska T.M. and Yaremko H.V. [3] emphasize the importance of implementing and supporting academic mobility in higher education institutions, as well as the process of internationalization of higher education, and argue that academic mobility of teachers can improve the quality of education, strengthen the link between science and industry, launch new academic careers and courses, and raise educational standards.

The authors Hryhoriv O., Mykhailyshyn L., Marusiak V. [4] investigate the information support of grant activities in the context of global economic crises, on the example of the management of cross-border projects of the Precarpathian National University.

Other important aspects include understanding the practice of using grants, their impact on the quality of research and educational programs, and analyzing the role of grants in the development of the innovation environment.

**Task statement.** The purpose of this study is to investigate and analyze the information support and trends in the development of grant activities in higher education institutions. To achieve this goal, it is planned to use a comprehensive approach that includes the analysis of scientific research, statistical data, information support, empirical research, as well as expert evaluation and comparative analysis of granting practices.

To analyze the main trends in the granting activities of higher education institutions. Identify promising areas for the development of grant activities. To assess the level of availability and quality of information on grant opportunities for higher education institutions. To formulate the existing problems of information support and grant activities in higher education institutions. To develop recommendations for improving information provision and adaptation of higher education institutions to new trends in grant activities.

**Results.**The main trends in the granting activities of higher education institutions include several key aspects, including increased competition for grants. These decisions are aimed at significantly improving the information support of grant activities in higher education institutions in Ukraine and increasing their success in attracting funding for research and educational projects. The introduction of such initiatives will help increase the availability of grant opportunities for teachers and researchers, which in turn will stimulate activity in conducting research and implementing innovative ideas.

Improved information support will also contribute to the development of scientific research in the country, as higher education institutions will be able to better navigate the available financial opportunities and grant programs. This will help create innovative solutions, develop new technologies, and increase the competitiveness of Ukrainian research institutions in the international scientific environment.

In addition, increased success in attracting funding will allow higher education institutions to expand their educational and research capabilities, introduce modern approaches to teaching and research, and attract talented scientists and students. In general, these measures will contribute to the improvement of the level of education and innovative development of Ukraine.

**Conclusions.** In the context of the topic of information support and trends in the development of grant activities in higher education institutions in Ukraine, the following conclusions can be drawn.

In the process of analyzing the main trends in the granting activities of higher education institutions, several key aspects were identified. Among them is the need to centralize information on grant programs and opportunities, which will simplify the process of finding and using financial resources for research and educational projects in higher education institutions. Also, the active involvement of international partners and experts in grant activities can help expand grant opportunities and exchange of experience in this area.

Assessing the level of accessibility and quality of information on grant opportunities for higher education institutions, the problem of lack of systematized information was identified, which requires the development of new approaches and ways to optimize information provision. The recommendations for the creation of a centralized information resource based on the Ministry of Education and Science of Ukraine for better information support of higher education institutions can help solve this problem.

In the context of assessing the problems of information support and grant activities in higher education institutions, the proposed recommendations for the creation of centralized web platforms with a collection of all available grant opportunities from state, international and private donors, which will be easily accessible to all higher education institutions, will contribute to the more efficient use of financial opportunities.

Thus, recommendations for improving information support and adapting HEIs to new trends in grantmaking include the creation of centralized information resources, active international cooperation, and the organization of specialized trainings and support for teachers and researchers. These measures are aimed at improving information support and increasing the success of grant activities in higher education institutions in order to stimulate research, innovation and educational initiatives of Ukrainian higher education institutions.
